(i) The promoter shall enter into an agreement for sale with the allottees in such format as prescribed under Rule 8(1) of the Odisha Real Estate (Regulation & Development) Rules-2017 henceforth;

(ii) The promoter shall execute a registered conveyance deed in favour of the allottee, along with the undivided proportionate title in the common areas to the association of allottees as provided in section, 17 of the Act.

(iii) The promoter in case of new project shall deposit seventy per cent of the amounts realised by the promoter in a separate & project specific account to be maintained in a scheduled bank to cover the cost of construction and the land cost and to be used only for that purpose as per sub-clause (D) of clause (I) of sub-section (2) of Section 4. As such the promoter shall not execute any agreement for sale or conveyance deed (sale deed) after 10.07.2022 without obtaining revalidated building plan approval or Occupancy Certificate from the competent Authority i.e. BDA, Bhubaneswar.**

(vii) The promoter shall disclose to the allottees regarding Bank Loan of Rs.30 crores as and when availed and consequential mortgaging of project land, if any.

(viii) The promoter shall comply with the provisions of the Act and the rules and regulations made thereunder;

(ix) The promoter shall not contravene the provisions of any other law for the time being in force as applicable to the project.

3. If the above mentioned conditions are not fulfilled by the promoter, the Authority may take necessary action against the promoter including revoking the registration granted herein, as per the Act and the rules and regulations made thereunder.
